WRIT OF SUMMONS

The Board of Directors (the "**Board**") of GCCP Resources Limited (the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce that the Company and its wholly-owned subsidiaries Gridland Sdn Bhd ("**GSB**" or "**Plaintiff 1**") and Hyper Act Marketing Sdn Bhd ("**Hyper Act**" or "**Plaintiff 2**") had filed a writ of summons (the "**Writ of Summons**") in the High Court of Malaya at Kuala Lumpur (the "**High Court**") against Loh Kok Hu (the "**Defendant**"). The Company, GSB and Hyper Act have been collectively named as plaintiffs (the "**Plaintiffs**") in the Writ of Summons.

The Writ of Summons was filed in respect of 2 invoices issued by the Defendant (the "**Invoices**") to Plaintiff 1 and Plaintiff 2 as well as various defamatory allegations (the "**Offending Statements**") made by the Defendant contained in the Invoices.

In the Writ of Summons filed against the Defendant, the Plaintiffs are claiming for (1) a declaration that the Invoices are null and void; (2) a permanent injunction restraining the Defendant through its servants/agents/employees/offices or otherwise howsoever from publishing or further publishing or cause to be published, circulated and distributing the Offending Statements or wordings to a similar effect which are defamatory of the Plaintiffs; (3) all documents belonging to and or relating to the Plaintiffs obtained, received, forwarded to the Defendant by the Plaintiffs or any other parties to be returned to the Plaintiffs within 30 days from the date of the order herein; (4) general damages; (5) exemplary damages; (6) aggravated damages; (7) costs; (8) interest at the rate of 5% per annum on items (3), (4), (5) mentioned herein from the date of the filing of the Writ of Summons till the date of full payment; and (9) such further and other relief as the High Court deems proper and just.

Pending the outcome of the High Court hearing, the Writ of Summons is not expected to have any material financial impact on the consolidated net tangible assets or consolidated earnings per share of the Group for the financial year ending 31 December 2015.

The Company will make further announcement(s) as and when there is any development in relation to the aforesaid matter.
